WHEREAS the Physicians desire to constitute a group arrangement as an unincorporated association (the "Association") in order for purposes including but not limited to selecting representative physicians for the Association Governance Committee (PAGC); selecting representatives for the broaderOHT Governing Committee (OHTGC); discussing clinical and policy matters regarding physician participation with respect to OHTs; and providing a forum for physicians to speak with one voice within theOHT catchment area;	We as physicians want to come together as an association so we can choose people to represent us both within our group and within any broader OHT governance structure. Our association also wants to discuss policy and clinical issues and speak on those issues with a unified voice.
AND WHEREAS the parties have entered into or are considering entering into participation agreements with otherOHT partners;	
AND WHEREAS in constituting the Association, the Physicians desire to set out certain administrative procedures and covenants which are fundamental to the operation of the Association;	Since we are forming this association, we want to develop some rules for how it will function.
AND WHEREAS the Physicians agree to conduct their affairs in a manner that promotes participation, collegiality, democracy, legitimacy, transparency and cooperation.	We want to make sure that we assemble our association

ARTICLE 3. MANAGEMENT OF ASSOCIATION

(a)	The Manager shall be responsible for the day-to-day management of the Association, subject to the direction of the Physicians. Activities may including scheduling meetings, preparing agendas, taking minutes, and coordinating elections.	
(c)	The Manager must be a Physician elected by the Group for an indefinite term or their representative or agent.	
(d)	The Manager's duties and responsibilities may be described in a written position description approved by the PAGC, and will also include such tasks as are assigned by the PAGC from time to time.	
(f)	The PAGC will decide on the process by which the Manager may be removed from office.	
(g)	The Manager may receive a stipend as determined byPA.	
3.03	Meetings of the Association	
(a)	Each Physician shall have an equal interest in the Association and shall be entitled to one vote on Amendments and with respect to Elections as set out in sections 3.04 and 3.05 respectively.	Each member of the association gets one vote on decisions and in elections.
(b)	The PA shall conduct regular meetings as required within theOHT catchment area. In addition, any Physician may requisition a PA meeting upon not less than fifteen days prior written notice to each of the other Physicians. Any such notice shall specify the date and place of such requisitioned meeting and shall include an agenda.	Any member of the association can call a meeting with 15 days' notice. An agenda is required when calling a meeting
(c)	The Manager shall keep minutes of all meetings and send notices as required.	
3.04	Amendments	
(a)	Decisions on amendments to this Agreement shall be voted on at a meeting or electronically.	If the association wants to change the terms of this agreeme
(b)	ThePA will approve any amendments only after approval by two-thirds of Participating Physicians who cast their ballot at a duly organized vote or meeting. Participating Physicians will receive at least fifteen days' notice of any meeting at which such vote will be taken.	at least 2/3 of the association's votes must approve the change. (a)	Physicians will vote for four (X) representatives to sit on the Association Governance Committee by secret ballot, which may be electronic, in person, or by proxy.

The members of that committee will be elected and should represent the types of physicians we have in our association. These are examples of types of physicians we might want represented. Different physician associations may have different groups of physicians listed here because the makeup of their group varies.

4.0 Meetings of the Physician Association Governance Committee	These are the rules for the group's Governance Committee.
 a) The PAGC shall meet monthly or as decided by the Chair with ten days' notice. b) Quorum for meetings of the PAGC shall be 50%+ 1 of the PAGC present in person or via virtual or teleconferencing tools. c) Voting shall be by consensus. If this cannot be achieved, a secret ballot shall be called requiring a 50%+1 majority. 	The Group's Governance Committee will meet once a month. The Chair may also call a meeting as-needed with ten days' notice. At least 50% of the Governance Committee's members must be able to attend in order for the meeting to take place.
4.01 Selecting members for the Broader OHT Governance Committee (a) The PAGC shall be responsible for selecting X physicians from amongst themselves to represent the PA on the broaderOHT Governance Committee.	When the Governance Committee votes on issues, all members must agree unanimously for the vote to pass. If the governance committee cannot get consensus, then they will have a secret vote. A 51% majority is needed to win
 (b) Any PAGC representative can submit their name for consideration. (c) At a minimum, there should be one primary care physician and one specialist physician selected. (d) The PAGC may use a third party (for example, a consulting company) to appoint from amongst themselves the X representatives using criteria to be determined in advance by the PAGC. 	 the secret vote. 5.0 Indemnification

It is acknowledged and agreed by each of the Physicians that this document is intended to be a shared decision making Agreement only and not in any way is it intended to establish or create a partnership. Nonetheless, there may be joint liabilities incurred for which each individual Physician could be exposed or responsible for an obligation of another Physician. In the event that their respective obligations and liabilities pertaining to the Association are several as to their respective interest, each Physician shall indemnify and save harmless the other Physicians (the "Indemnified Parties") from any and all claims, losses or liability whatsoever in excess of the Indemnified Parties' pro-rata share. Any Physician whose negligence or wilful misconduct has given rise to such claims, losses or liability shall not be entitled to the benefit of the protections provided in this paragraph.

6.0 Entire Agreement

This Agreement constitutes the entire agreement between the Physicians and except as herein stated and in the instruments and documents to be executed and delivered pursuant hereto, contains all of the representations and warranties of the parties. There are no oral representations or warranties among the Physicians of any kind. This Agreement may not be amended or modified in any respect except by written instrument signed by all Physicians.

7.0 Successors and Assigns

This Agreement shall enure to the benefit of and be binding upon the parties and their respective heirs, successors, estates and assigns.

8.0 Severability

In the event that any one or more of the provisions of this Agreement shall be held to be invalid or unenforceable by a court of competent jurisdiction, such provision(s) shall be deemed not to have been written and shall not affect the validity or enforceability of any other provisions of this Agreement.

IN WITNESS WHEREOF this Agreement has been executed by the parties hereto.

Sample Physician Association Agreement

This document is meant to establish an agreement about how the association will make shared decisions. It is not intended to form a corporation or any other kind of partnership.

However, if the group of physicians in the association becomes liable for something, then the members of the association agree to share the responsibility equally unless one person is specifically responsible. In that case, the one responsible person agrees to pay for the others beyond the equal share. For example, if the association hires a staff person and then later decides to terminate them, the members of the association would need to split the termination pay for the staff person equally.

The risks associated with this part of the agreement are exceedingly low at this point since most Physician Associations do not currently have any funds.

This document is the entire official agreement for the association. This agreement overrides all other agreements made at any other point in time (whether verbal or written).

If the group of physicians in our association is found jointly liable for something and then you pass away, your estate would be responsible for paying your share. For example, your estate would be responsible for paying your share of the termination pay for the employee from the previous example.

Again, the risks associated with this part of the agreement are exceedingly low at this point since most Physician Associations do not currently have any funds.

If a court of law rules that part of this agreement is not valid or not enforceable, the rest of the agreement is still valid.
